 - Barry spoke w/ Matt Galas, who says he is in a much better insurance position than thought
 - Coverage up-to \$500,000
 - This should be more than enough to cover a full rebuild
 - Remuneration Insurance up-to \$250,000
 - Windy City Curling vs. Curling Club Community
 - WCC's losses are not covered
 - CCC will work with WCC to get as much covered as possible
 - Letting CCC get their insurance coverage happen first
 - Galas is going to fight to have our \$2,000/week fee covered
 - Streaming equipment should be covered

- Club Financials Eric B.
 - Currently holding: \$45,700 in checking & \$61,000 in savings
 - Balance sheet and short-term financial needs
 - Look into getting Property Insurance for Windy City Curling
 - Cover the Stones, other WCC's physical holdings within the club
 - Refunds
 - PPL & AYCC for Session 4 Email w/ Google Form asking for league fee donations
 - No response by cut-off date = Refund Issued
 - 30-day timeframe
 - People requesting a refund will get them as soon as possible
 - Memberships for 13 recent WCC members = requesting donations as well
 - PVA "Pick Up Sticks" refunds to issue as well Barry H. will get list to Eric B.
 - WC3 Open Bonspiel
 - Bonspiel canceled Aaron D. will gather list of teams to refund
 - Stripe has paid out most fees, so many of these refunds will come from our Checking account (Overall risk = \$40k, vs. \$45k on-hand)

 - Offering to hold a Watch Party on both Saturday (1-7pm) and Sunday (12pm-6pm)
 - Anyone who present either an announcement email or social media post... will have 15% of their tab contributed to WCC as a fundraiser
