Agenda:

- Sponsorships Matt Ault
 - This season's sponsorships set to expire this Summer '24
 - Looking to pitch in-ice graphic sponsorships with the ice rebuild
 - Branded Houses, ice logos, etc.
 - The present idea is to freeze any sponsored graphics into the ice at a more shallow layer, so they're able to be swapped out without a full melt
 - Matt Ault is requesting to take the lead on generating new sponsorships
 - MOTION: Eric R. To approve Matt Ault to take the lead on volunteerism
 - SECOND: Anne P.
 - VOTE: Tabled pending a conversation with Matt Galas
- Bonspiels and events and year end meeting and Spiel Aaron D.
 - Host a Funspiel and Fundraiser at Chicago CC in May 4-5, 2024:
 - Saturday & Sunday event, culminating w/ the Annual Meeting
 - Colleen & Colin volunteering to take the lead
 - Need to figure out the particulars yet Pricing, Registration Setup

- Hold a League-friendly tourney in tandem with a fundraiser?
 - Saturday, April 13th to play Two 6-end games
 - Need to field four teams from Windy City

- Rebuild Overview Matt G.
 - Mitigation and Demo is complete
 - Currently "sitting and waiting" for everyone else to catch up with us:
 - The roof above us needs to be closed up, and approval has been given
 - Rain still comes into our space at-present, although it's minimal
 - Goal is to have everything sealed up and waterproof by next week
 - o Timeline is to have us open again in mid-August
 - Dependent on the roof above us being fixed first
 - Chiller coil fix likely coming in May, to help for the Fall
- Club Financials Eric B.
 - February 2024 financial overview
 - Expenses came in at 92% of budget
 - We're under budget by \$3,000 this year (based on last year's projections)
 - Mix of: Lower membership this year & AYCC vs. PPL
 - Overall liability vs. Cash-on-hand we're in a good spot

 - VOTE: Motion passes, 5-0 (One vote absent)
- Refund Update:
 - 42 people have donated their league fees
 - 17 people have requested refunds
 - All except 1 WC3 bonspiel teams have been refunded
 - 1 team requested to donate their fees
 - Refunds to be issued for remaining league fees on April 10
- GoFundMe currently sitting at \$42k+ out of a \$50k goal
- Leagues and length of leagues for next year Anne P. and Eric R.
 - Competitive Leagues (Mixed, open competitive, and doubles) will run a half season ~15 weeks.
 - Social/ developmental leagues will run a quarter season ~5 to 8 weeks
 - This was decided at the last board meeting
 - o MOTION: Host the 5-and-Under Cashspiel on Oct. 3-6 Barry H.
 - SECOND: Aaron D.
 - VOTE: 5-0-1, Passes (1 abstain)

 - GoFundMe plan
 - Update on Donations
 - Stock donation
 - Members gave cash instead to GoFundMe campaign
 - AnyWays Restaurant Brier Watch Party
 - \$300 from Anyways
 - Circle City Curling Club
 - Sent us a \$1,000 check

- Sponsorship Discussion Matt G.
 - Ads in the Ice-
 - Non-house ads can be put higher in the ice to potentially swap out every summer "soft melt"
 - Custom-designed ice houses would have to stay in through a full melt
 - Split of income-
 - CCC will collect the income from all sponsorships, which will then pass through to WCC via our annual profit sharing
 - Board will discuss via Slack for 72 hours upon receiving the proposal from Matt A
 - Will then take 48 hours to hold the vote online

 - We'll try this out for the next meeting
